APPENDIX 'I' SUPPLEMENTAL DATA INSTRUCTIONS

This purchase order imposes data requirements which must be submitted to Buyer. This Appendix provides specific submittal instructions for the initial data package and maintenance thereof required in performance of this purchase order. Any exceptions to the data requirements imposed by this purchase order must be resolved prior to purchase order award.

- All Data submittals shall be by letter or packing sheet and as a minimum shall reference this Purchase Order and identify the Data being transmitted by Data Sequence Number (DSN), and applicable Part Number (Lockheed Corporation P/N and Vendor P/N).
 - a. The Data Sequence Number (DSN) is a four-digit reference number that is indicated in the schedule section of 16PP148 data document. The DSN number listed will always identify a particular data requirement contained within the 16PP148 data document. For example, DSN 1710 identifies an Acceptance Test Procedure (ATP), and is the only DSN to properly identify the ATP.
- When submitting documents such as plans, reports, specifications, procedures, etc., list the document number, its revisions and date and APPLICABLE PART NUMBER(S) on the transmittal letter or packing sheet.
- 3. When submitting drawings, diagrams, schematics, LM's, etc., provide a listing of the drawings that make up the package showing drawing number and revision level.

One copy of all transmittal letters and packing sheets will be forwarded direct to the Buyer. (see attached sample format). 6. All technical data pertaining to items, components or processes developed at private expense and, which has been previously certified as such by Seller to Buyer, shall be identified as limited rights data in accordance with DoD FAR Supplement 252.227-7013, "Rights in Technical Data and Computer Software," and the legend set out therein.

NOTE: INCLUDE IN THE LIMITED RIGHTS LEGEND A) THE NUMBER OF THE PRIME CONTRACT UNDER WHICH THE TECHNICAL DATA IS TO BE DELIVERED, B) THE NAME "LOCKHEED CORPORATION" AS THE PRIME CONTRACTOR AND YOUR NAME AS THE SUBCONTRACTOR BY WHOM THE TECHNICAL DATA WAS GENERATED, C) AN EXPLANATION OF THE METHOD USED TO IDENTIFY LIMITED RIGHTS DATA.
